Memorandum of Understanding

On Exchange of Students / Staff / Faculty

Between

And

GOVT.COLLEGE BARAMKELA, RAIGARH (C.G.)

Vishnu Charan Gupta Govt. College Pussore, Dist. Raigarh(C.G.) This Memorandum of Understanding (MoU) is effective as of 15.09.2020 (effective date) to establish an affiliation by and between

V.C.G.Govt.College Pussore, Raigarh(C.G)

And

Govt.College Baramkela, Raigarh (C.G.)

For the purpose of exchange of faculty, staff and students.

Preamble

Whereas, both colleges have many areas of common interest in Science, Arts and Commerce, considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academics, cultural and other activities.

Therefore, both colleges have decided to enter into this Memorandum of Understanding (herein after referred to MoU), which defines the framework for the cooperation of the two institutions set out in the following sections.

ARTICLE 1: OBJECT

Both institutes agree to develop the following collaborative activities in the academic areas of mutual interest.

The two institutes shall seek to promote:

A. Faculty / Staff Exchanges

- (i) The exchange of faculty to the mutual benefit of both institutes.
- (ii) Collaboration in teaching in the field of mutual interest.
- (iii) Conducting lectures.

Vishnu Charan Gupta Govt. Colleg Pussore, Dist.- Raigarh(C.G.) (iv) Short term attachment of faculty for purposes of upgrading of teaching.

(v) Participating in seminars , symposiums and other types of academic discussions.

(vi) Conducting study tours.

B. Student Exchange

Both colleges agree that student exchange will be guided by principles listed below. A home institution refers to the institution where a studnt is a full-time student, and from where he/she is expected to graduate. A host institution refers to an institution that receives a student for a brief period of time to undertake a pre-determined programme of study.

1. Exchange students will be selected by mutual agreement between the home institution and the host institution.

2. An exchange student will continue to be treated as full-time student at his/her home institution.

3. An exchange student will be considered as full-time "exchange" student at the host institution.

4. His/her programme of study at the host institution will be determined by mutual consultation between his/her academic advisor at the home institution and his/her "interim" academic advisor identified by the host institution.

5. The host institution will evaluate an exchange student's performance in each course or module and will award a certificate to that effect.

6. Expenses for accommodation, living or travel will be beared by students concerned.

7. The exchange students will pay tuition and other fees at their home instituton.

C. Other Areas:

- 1. To exchange information on teaching, learning material and other literarure relevant to their educational and research programme.
- 2. To jointly organize short-term continuing educational programs on topics of mutual interest and to invite each other's faculty to participate.
- 3. To jointly organize seminars, conferences or workshops on topics of mutual interest and to invite each other's faculty to participate therein.
- 4. The provision of cultural and intellectual enrichment opportunities for staff and students of both institutes.
- 5. To use laboratory facilities in specific areas for a limited period.
- 6. To permit students, staff and faculty members to use library facilities.

ARTICLE 2: COORDINATION

Each institution shall appoint one member of its teaching faculty to coordinate the programme on its behalf. They will periodically review and identify ways to strengthen cooperation between the two institutions.

ARTICLE 3: VALIDITY

The Memoandum shall remain in force for a period of FIVE years commencing from effective date. Institutions may extend the term by written agreement signed by both after review.

Either institution may terminate the MoU by giving written notice of six

months in advance to the other institution. However, both institutions

will ensure that the provisions of this Memorandum shall continue to

apply to all activities in progress until their completion.

ARTICLE 5 : AMENDMENTS / MODIFICATIONS

This MoU may be amended or modified by a written agreement signed

by the epreentatives of both institutes.

ARTICLE 6: ADHERENCE TO LAWS

Participating faculties , staff and students involved in any activities

under this Memorandum must adhere to the law of host institution.

ARTICLE 7: LEGAL EFFECT

Nothing in this Memorandum shall be construed as creating any legal

relationship between the institutes. This Memorandum is a statement of

intent to foster genuine and mutually beneficial collaboration.

ARTICLE 8: DISPUTE RESOLUTION

In case, there be a dispute relating to any aspect of academic

cooperation, Principals of both institutions will jointly resolve the

dispute in a spirit of independence, mutual respect and shared

responsibility.
